Overview

Recent developments

The global economy grew 3.3% in 2013, slightly higher than the estimate published in the March *Monetary Policy Statement*.

The NRBT estimated a much stronger real GDP growth, of 2.5% in 2013-14, an upward revision from the March MPS estimate of 2.0% growth. The upward revision reflects a much stronger than expected second half to the year owing to availability of data for the agricultural and tourism sectors which were offset slightly by a softer growth in the construction sector.

The balance of overseas exchange transactions was in surplus T\$27.7 million over the year to August 2014, wider than the surplus of T\$23.1 million recorded over the year to February 2014. Remittances, which account for the major portion of current account receipts, have changed only slightly over the past six months. Over the year ended August, total remittances is around T\$210.7 million.

Credit growth has picked up and interest rate spreads continue to narrow. In line with banking system liquidity, foreign reserves continue growing and remain well above the minimum range.

Net credit to government fell by more than 15% over the year to August 2014. The outcome reflects an increase in government deposits more than offsetting an increase of banks' holdings of government bonds.

Outlook

Global growth has been lower than expected in the first half of 2014, leading the IMF to downgrade growth expectations to 3.3%.

The NRBT's outlook for Tonga is positive with GDP growth around 2.9% in 2014-15 and 3.1% in 2015-16. The expected drivers of the growth are construction, agricultural and tourism sectors.

The NRBT projects that headline inflation will fall to around 1.3% at the end of this year. This is firmer than the 0% projected in the last statement. Global economic uncertainties and weather patterns pose large risks to the inflation outlook.

Foreign reserves are projected to remain well above the NRBT minimum range into early 2015. Despite the expected strong credit growth and associated deterioration in the trade balance, the receipts of government budget support are expected to maintain the foreign reserves at high levels. Remittances are also expected to rise, although the growth will be slow. Growth in travel receipts are likely to pick up.

Broad money is expected to increase as a result of a projected increase in credit growth. The NRBT will continue to liaise with the banks to encourage prudent lending. Low interest rate spread is expected to continue and support lending growth.

Continued coordination of fiscal policy and monetary policy between NRBT and Ministry of Finance and National Planning is of great importance to ensure the relevant objectives are achieved and at the same time, contribute to the stimulation of economic activity.

As foreign reserves levels are expected to remain high, inflation within the reference range and the economy is likely to be operating with excess capacity for some time, the NRBT expects to continue implementing a monetary policy setting that is as supportive as possible for economic activity over the near term.


1. Global developments

World growth

The global economy grew 3.3% in 2013, slightly higher than the estimate published in the March *Monetary Policy Statement*. The first half of calendar 2014 saw lower than expected growth, urging the IMF to revise growth expectations down to 3.3%.

Major economies

The economic recovery in the United States has progressed broadly above expectations over the first half of 2014. GDP grew 4.2% in June, and the unemployment rate has declined to 6.1%. Despite upbeat developments, the Federal Reserve is expected to maintain near-zero interest rates until around mid-2015.



The euro zone is still experiencing challenges following the Global Financial Crisis, with inflation and GDP barely above zero. In September, the European Central Bank announced new stimulus efforts and reduced its deposit facility to -0.2%.

Chinese economic growth remains subdued by recent historical comparison, however, stable and consistent with expectations. The economy grew 7.5% in 2013-14, with stable unemployment and 2.0% inflation, well-below the annual threshold. A record trade surplus in July has reinforced confidence in the economy, increasing the likelihood of a decision to appreciate the currency.

Conditions in Japan continue to recover moderately in trend terms, although weakness in demand has been observed. As inflation declined and the unemployment rate etched higher, the Bank of Japan maintained its record stimulus in September.

The Australian economy has shown to be more robust than expected, with a 3.1% expansion over the year to June 2014. Despite the structural changes occurring in the mining sector, this was the largest contributor to growth, followed by the financial services and construction sectors. The unemployment rate is steady at just above 6% and inflation is in line with the target at 3.0% in 2013-14. The Reserve Bank of Australia is expected to maintain official interest rates at 2.5% until well into 2015.

The New Zealand economy expanded by 3.9% over the year to June 2014, reflecting ongoing strength in consumption, business investment and construction activity. Inflation is at the lower end of the target range at 1.6%, and the unemployment rate remains low at 5.6%. The Reserve Bank of New Zealand maintained the official cash rate of 3.5% in its September Board meeting, signaling that it may slow the pace of monetary tightening going forward.


World oil prices

In US dollar terms, world oil prices have decreased by 10.8% over the six months to August. This largely reflects weak demand growth from North America, euro zone and China, as well as new supplies in the US coming online. In pa'anga terms, oil prices have decreased by 8.7% over the same time.

South Pacific economies

Growth outcomes in the main South Pacific economies are expected to improve in 2014, with only Solomon Islands expecting subdued growth. Fiji's growth is expected to dampen in 2015. This will be in contrast to faster growth expected for the rest of the economies in the region, with Papua New Guinea anticipating a national record 21.6% growth due largely to the production of liquefied natural gas coming online. Growth in 2016 is expected to be lower in Fiji, Samoa and Papua New Guinea in comparison to 2015. While in the other South Pacific countries, soft growth is anticipated.

Inflation across most South Pacific economies is expected to rise in 2014, with the exception of Fiji. The IMF expects inflation to rise further in 2015, except for Papua New Guinea and Solomon Islands. Inflation expectations are broadly higher for 2016.

2. Developments in the Tongan economy

Real GDP Growth

Since the March *Monetary Policy Statement (MPS)*, the Tonga Department of Statistics has released the official estimates of real GDP showing a contraction of 3.0% for 2012-13.

The NRBT estimated a much stronger real GDP growth, of 2.5% in 2013-14, an upward revision from the March MPS estimate of 2.0% growth. This reflects a much stronger than expected second half

to the year owing to availability of stronger data for the agricultural and tourism sectors which were offset slightly by a softer growth in the construction sector.

The NRBT's outlook for Tonga is positive with GDP growth around 2.9% in 2014-15 and 3.1% in 2015-16. The expected drivers of the growth are improvement in construction, agricultural and tourism sectors.

Primary Sector

The agricultural sector, which accounts for 15.0% of GDP, showed signs of strong growth over 2013-14. Data shows export volumes grew by 5.1% while the value and volume of domestic sales grew by about 20% and 22% in real terms respectively. There were some new areas of primary activity, including the butterkin squash. New lending via the Government's agricultural marketing fund would have also provided some stimulus to the sector. NRBT liaison with growers also suggests that steady rain and good weather conditions supported the large harvests during 2013-14. NRBT expected that value-added to the sector grew by around 4.0%.



Looking forward, activity in the agricultural sector is expected to experience subdued growth in 2014-15 following a very strong year and will rebound back up in 2015-16. Agricultural funds and the ongoing progress in the 'Agricultural Sector Plan' will provide stimulus and direction for the sector. Growers are also expanding the range of crops they export to Australia, New Zealand, Fiji and Samoa. Liaison suggests exporters' confidence in the market remain high despite expectation that coconut exporters are to lose market share, as Samoan competitors continue to recover from Cyclone Evan. Ha'apai production is also expected to recover, albeit slightly, which should contribute to growth. However, deterioration in weather conditions still pose a significant risk to the outlook, as in the current 'El Nino' warnings and signs.

The fisheries industry is also expected to grow steadily due to an increase in number of locally based commercial vessels in operation and also some local fishing companies have managed to penetrate to the NZ market with frozen fish. At the same time, government incentives such as the Fisheries Development and Export Fund (FDEF) and a recent removal of taxes on fishing gear are supporting longer-term growth prospects. However, like agriculture, weather conditions may also affect the output in the industry.

Secondary Sector

Construction activity recorded strong growth in 2013-14, supported by a marked increase in public works. Major projects during the financial year include an upgrade to the Tongatapu airport, the installation of a submarine optic fibre cable, and various projects included under the Tonga Energy Road Map.

The delays to the Ha'apai reconstruction and other various projects contribute to the positive outlook for the sector and the economy as a whole in 2014-15. The outlook is positive as there are a number of projects in the construction pipeline, such as the building of the St. George Palace and the Faua wharf project. Also the NRBT expects construction work in preparation for the South Pacific Games to come online within the next few years driving growth for 2015-16 onwards. An increase in private works is also expected.



The developments in the construction sector are expected to have some spillover effects for mining and quarrying activities, manufacturing and the utilities sector. The utilities sector is expected to benefit from the growth in the number of buildings and construction work happening throughout the years.

The manufacturing sector is also expected to benefit from the construction activity through the demand for raw materials such as bricks and paints for housing. Also, anticipated recovery of plantations used for handicrafts in Ha'apai will also help boost activities in the sector. NRBT also expects growth in tourist arrivals in the near future to stimulate activities in the handicrafts sector through increase demand.

Tertiary Sector

The distributive and trade sector is expected to record strong growth over 2013-14. Total container registrations rose by 17.4%, due mostly to a strong rise in private container registrations. This suggests much of the growth to be in the less formal parts of the sector, such as roadside fairs. Business container registrations also gained, albeit slightly. The Statistics Department has not yet released imports data for the second half of 2013-14; however, information from import payments made through the banking system also showed growth.

The sector is expected to grow steadily, benefiting from a pick-up in household lending activity, as will the finance sector. However, the recent depreciation in Tonga's real exchange rates poses a risk to the growth in the distribution sector.

The NRBT estimated the finance and insurance sector expanded, demonstrated by a steady rise in bank lending in 2013-14. The finance component alone is estimated to have increased by 5.0% in real terms. Bank lending is anticipated to continue to grow supported by an increase in government grants and incentives.


While visitors' arrivals data for 2013-14 are not yet available, other partial indicators show growth in the tourism sector. The number of cruise ships during 2013-14 doubled that of the previous year. Travel receipts, as recorded in the banks' overseas exchange transactions, also noted a 6.9% growth over the year. Offsetting these were disruptions with the domestic air services and the damages to the sector sustained in Ha'apai during Cyclone Ian.

The outlook for tourism is positive supported by continuing economic growth in the key source countries. The travel ban that was imposed on the domestic airline services has been lifted and the NZ grant for tourism is forthcoming. Government grants are also available to provide incentives for growth in the sector.

Unemployment

Comprehensive and timely labor market data are unavailable in Tonga. The last official release for the unemployment rate was part of the 2011 population census, which stated that, including discouraged workers (an uncommon approach in metrics produced overseas), the Tongan unemployment rate was 6.5%. Tonga's unemployment figures are difficult to compare with other countries because of a high incidence of subsistence work.


The NRBT is trying to investigate new avenues for the production of more timely labor market data.



3. Promoting Low and Stable Inflation


Recent Developments

Consumer prices rose over the 12 months to August 2014 by 2.5%. This rate was around 3 times higher than over the year ended August 2013, but still lower than the 4.7% rise over the year ended February 2014. Prices have remained well below the NRBT reference range of 6 to 8%.





Major contributor to imported inflation is the strong New Zealand dollar, although it slightly depreciated against the pa'anga, over August. World oil prices, measured in pa'anga fell over the past year by 11%, keeping growth in imported transportation prices down.


The increase in consumer prices was mainly driven by a 4.8% rise in prices of imported goods, compared with 3.2% at the time of the last statement. This rise is broadly below the average of the past 5 years. The largest increase in imported prices was for food, particularly for meat and dairy sourced from New Zealand. Strong increases in imported clothing and footwear prices are still evident, after having not been surveyed for 3 years. This increase has a minor impact on overall inflation, given its low weight in the consumer price index basket. Prices of domestic fuel and power (a subset of household operations component) increased slightly over the year, consistent with the decline in electricity prices over that time.

The prices of goods produced domestically dipped by 0.9% over the past year, lower than the 6.8% increase over the year ended February 2014. This soft outcome, similar to imported inflation, is also broadly below the average of the past 5 years. Declines in domestic prices were driven by a fall in Fruits & vegetables, and Meat, fish & poultry prices. Prices of Fuel & power fell also, coinciding with a 6% decline in world oil prices.


The rate of core inflation, which excludes imported food and imported energy prices, increased slightly over the year to August by 0.5%. This increase is lower than the 2.9% rise recorded over the year to February 2014.

Outlook


The NRBT projects that headline inflation will fall to around 1.3% at the end of this year, which is firmer than the 0% projected in the last statement. The main factors that caused the difference were the underestimated increases in the prices of domestic fruits and vegetables earlier this year, due to the severe summer weather conditions. Imported prices, particularly prices for food, increased gradually since the last statement, driven mainly by the strong New Zealand dollar. Most of Tonga's imported food is New Zealand made.

The forecast is based on three key factors:

- The IMF expects world food prices to be about 7% lower over calendar year 2014, owing to an increase in world food supply.




- Market economists expect world oil prices to fall by 12% over calendar year 2014, due to a lift in global supplies amid elevated political tensions in some oil-producing countries.
- Exchange rates are assumed to be unchanged.

Global economic uncertainties and weather patterns pose large risks to the inflation outlook. With the impact of El Niño and effects of the August and September drought, inflationary pressures on domestic prices may increase in the near term.

4. Maintaining Adequate Foreign Reserves


Balance of Overseas Exchange Transactions

The balance of overseas exchange transactions was in surplus T\$27.7 million over the year to August 2014. This surplus was wider than that over the year to February 2014, which recorded a surplus of T\$23.1 million.


The year-ended export receipts have risen by 31.8% and have been steadily rising since over the year to February. They are now at high levels by recent standards. Increased activity in the primary sector is largely supported by a rise in agricultural and marine export receipts.


Current Account

Year-ended merchandise import payments rose by 4.2% over August, higher than over the past six months. The payments for the major components, oil and retail goods, have shown a slight decrease which is in line with the lower world oil prices limiting the rise in imported inflation. This was more than offset by higher payments for imports of construction materials, motor vehicles and other household. This is consistent with growth in banks' lending for housing. Higher container registrations support the rise in import payments. The corresponding data from the Statistics Department are not yet available.

Remittances, which account for the major portion of current account receipts, have changed only slightly over the past six months. Over the year ended August, total remittances is around T\$210.7 million compared with T\$212.9 million over the year ended February. The slight decline stemmed from New Zealand sources, although positive growth was recorded from Australian and US sources. Australian remitters accounted for the largest share, at 35%, followed by the US at 28% and New Zealand at 25%.


Capital Account and Unclassified Transactions

Net capital inflows totaled T\$98.5 million over the year to August most of which were private capital inflows. The transfers were lower than over the year to February, due to fall in official capital grants from overseas.

The balance of unclassified transactions was an average outflow of T\$1.4 million per month over the year ended August 2014. The NRBT is looking at possible sources for this discrepancy to be addressed.

Official Foreign Reserves

Gross official foreign reserves increased by 1% from February 2014 to T\$283.9 million as at the end of August 2014. This is around 11% higher than August 2013. The level of reserves is equivalent to 9.3 months of imports, well above the NRBT minimum range of 3-4 months of imports.



Exchange Rates

The Nominal Effective Exchange Rate (NEER) index fell by 0.1% over the six months from February, implying a depreciation of the pa'anga against its major trading partners. The Real Effective Exchange Rate (REER) fell by 1.9% by comparison.

The exchange rate spreads charged by the banks are higher in Tonga than in other Pacific countries. The NRBT has imposed limits on the spreads on telegraphic transfers only since 2009. The limits are subject to annual review.

Outlook

The NRBT expects the level of foreign reserves to remain well above the NRBT minimum range throughout the remainder of 2014 and early 2015. The anticipated increase stems from a balance of key factors:


- Remittances will probably rise, although the growth will be slow.
- The trade balance is expected to deteriorate with higher imports being fuelled by firmer lending outcomes.
- Growth in travel receipts are likely to pick up, based on liaisons with the domestic airline who are optimistic despite the airline related disruptions to the tourism industry imposed by New Zealand.
- Budget support to pick up in the second half of 2014-15 year following the November elections.

5. Monetary Conditions

Credit growth has picked up and interest rate spreads continue to narrow. In line with banking system liquidity, foreign reserves continue growing and remain well above the minimum range. The NRBT incorporates the data from Pacific International Commercial Bank in this Monetary Policy Statement.

Interest Rates

The weighted average interest rate spread declined to 6.7% in August 2014, compared to 7.0% in February 2014. This is mainly due to a rise in deposit rates and a decline in lending rates. This indicates that banks are building up their deposit base to fund the expansion of their loan books. The increased competition among banks also contributed to the narrow interest rate spread.




The weighted average interest rates on the key bank lending categories except 'other personal' fell over the six months to August 2014. The weighted average rate on all bank loans fell by 7 basis points due mainly to banks offering competitive interest rates on loans to prime customers such as the public enterprises.

The fall in weighted average rate on all bank loans creates a response in business investment activity and consumer borrowing, evident by a rise in new commitments to housing, manufacturing, agriculture and especially construction.

Lending rates over the six months to August were the lowest since at least January 2001, although recent improvements to reporting requirements are complicating historical comparisons.

On the other hand, weighted average deposit rates rose by 21 basis points over the six months to August, driven by an increase across all deposit categories particularly term deposits. The increase in weighted average deposit rates reflected the entrance of the new Pacific International Commercial Bank offering relatively higher term deposit rates compared to the existing banks, with the exception of MBf. The increase in term deposit rates also reflected the reinvestment of government's matured term deposits at a longer term with one of the banks.



Lending and Deposit Balances

Total bank lending balances rose by 9.4% over the year to August 2014, higher than the growth of 8.9% over the year ended February 2014. This growth was driven mainly by an increase in lending to businesses and households. Including loans extended by the Retirement Fund Board (RFB), South Pacific Business Development (SPBD) and Government of Tonga (both for building reconstruction and other), lending would have grown by 10.6% over the year.

Bank lending balances to households grew by 6.2% over the year to August, owing to a rise in housing and other personal lending. The increase in housing loans coincided with an increase in import payments for construction materials. In addition, the rise in other personal lending indicated the continuous demands for funds by private individuals. New household commitments are at high levels by historical standards. Furthermore, after adjusting for the non-bank lending programs, year-ended growth in household lending would have been around 13% (though some of the extra household lending balances would ideally be classified under business lending).


Household Lending Balances

Business lending balances rose by 13.0% over the year to August 2014 due to substantial increase in lending to public enterprises. New business commitments grew over the year to August 2014 particularly the construction and agricultural sectors. This reflects the reconstruction at Ha'apai and commencement of the squash season. Including loans extended by non-banks, the business lending balance rose by 8.2% over the year to August 2014.

Over the year to August, broad money balances rose by 6.0% led by a growth in net foreign assets which reflected an increase in foreign reserves, and the positive credit growth. Furthermore, an increase in currency in circulation and saving and term deposits also contributed to the rise in broad money.

This is partly explained by a rise in government deposits. Banking system liquidity rose by 7.0% over the year to August, largely underpinned by the rise in government deposits. An adequate liquidity margin for prudent lending remains, particularly in short term deposits.

Outlook

Credit growth is supported by the continuous improvements in business confidence and lending conditions. Increased competition in the sector will continue to support lower lending rates however, banks have indicated significant declines are unlikely.

The NRBT is forecasting credit to grow by around 10% in the next six months. This is on the basis

of imminent drawdowns of some large loan commitments including public enterprises, the expected fall in interest rates, and the introduction of the government's new loan scheme targeting the manufacturing, tourism, agricultural and fisheries sectors as well as education loans. Credit growth is expected to increase slightly in 2014-15. The NRBT will continue to encourage prudent lending, and maintain close liaison with banks.

6. Fiscal overview

Net credit to government fell by more than 15% over the year to August 2014. The outcome reflects an increase in government deposits by around 15%, more than offsetting an increase of around 11% in banks' holdings of government bonds. This largely reflects government receipts from development partners, higher revenue collection and tight fiscal policies constraining expenditures by ministries during the period. The increase in government deposits also contributes to the rise in broad money and foreign reserves. This coincides with the estimated budget surplus of T\$8.6 million announced in the 2014-15 Budget Statement for 2013-14.

A budget deficit of T\$13.7 million is expected for 2014-15. To assist in financing the budget deficit, government bonds were issued in the first half of the 2014-15 facilitated by the NRBT, to fund the Government's private sector loan scheme which is managed by Tonga Development Bank (TDB). Given the high Exchange Settlement Account (ESA) balances and the intended use of the government bond proceeds, issuance of government bonds would not have a material impact on banking sector liquidity.

With the amendments to the NRBT Act, the NRBT will be able to underwrite any undersubscribed bonds. The successful implementation of the loan scheme would put pressure on the foreign reserves and will result in higher credit growth hence lower broad money. Therefore it is important that NRBT encourages prudent lending of government funds by TDB.

The Government also introduced two years private sector investment incentives in August 2014 including time-limited tax exemptions, streamlined procedures for businesses seeking specific incentives beyond the standard ones provided and small business tax for business with turnover up to \$100,000 to lighten the preparation of tax returns by small businesses. This may lessen government revenue collection during this period. Yet, it is expected that these government initiatives will assist private sector growth plans and government revenue collection in subsequent years.

Government receipts are expected to increase in the latter part of 2014-15 mainly from budget support and the Ha'apai housing reconstruction project. It is projected this will maintain foreign reserves months of imports cover above 8 months in the near term, well above the minimum range of 3-4 months. Net credit to government is also expected to increase.

Similarly, an 8.9% increase in public debt announced in the 2014-15 Budget Statement to finance the budget deficit will further contribute to the increase in net credit to government. Given that more than 90% of the debt is in the external component, this would result in outflows in the foreign reserves in years to come. The NRBT continues to encourage continued coordination of its monetary policy and the fiscal policy of the Ministry of Finance and National Planning to ensure the respective objectives are achieved and result in stimulating economic activity.

7. Monetary Policy Stance

Maintaining an adequate level of foreign reserves and promoting price stability are the main monetary policy objectives of the NRBT.


The NRBT's accommodative monetary policy stance remained unchanged since November 2012 when the 1% interest rate paid on the ESA balances was removed. The NRBT has not issued any NRBT notes and has maintained the Statutory Required Deposit ratio at 5% of deposits. The NRBT has decided not to absorb the banking system liquidity in order to encourage banks to mobilize assets for new lending.

Supported by the recent global economic recovery and growth in the construction,


agricultural and tourism sectors, the NRBT's outlook for Tonga is quite positive. Bank's credit growth will continue to increase and weighted average interest rate spreads continue to narrow. However, government receipts of budget support and expected higher remittances and travel receipts are expected to maintain the foreign reserves at high levels, well above the minimum range. Inflation expectations remain well within the NRBT's reference range.

Considering these developments, the current accommodative monetary policy setting is considered appropriate in the next six months. Nevertheless, NRBT will continue to closely monitor the country's economic developments and financial conditions and to adjust if needed.


Appendix 1: Tongan Pa'anga Exchange Rates







Appendix 2: Monetary Policy Objectives

The NRBT's obligations with respect to monetary policy are laid out in Section 4 (1) of the National Reserve Bank of Tonga (Amendment) Act 2007, which state that the principal objectives of the Bank shall be to:

- (a) maintain internal and external monetary stability; and
- (b) promote a sound and efficient financial system;

Section 4 also states that the Reserve Bank will conduct its activities in a manner that supports macroeconomic stability and economic growth. In addition, Section 30 (2) of the Act gives the Reserve Bank the responsibility of maintaining an adequate level of foreign exchange reserves.

Under the Act, the Reserve Bank shall maintain internal and external monetary stability through maintaining official foreign exchange reserves and promoting price stability.

Maintaining an adequate level of foreign reserves is vital for a small open economy such as Tonga. It is dependent on imports for the supply of most of its goods, which needs to be paid for in foreign currency. Given Tonga's vulnerability to external shocks and natural disasters, its small size, narrow export base, and dependence on imports, it is imperative that foreign reserves are maintained at an adequate level to meet individuals' needs for basic essentials and support economic growth.

An adequate level of foreign reserves also minimizes volatility in the exchange rate and provides confidence that businesses and individuals in Tonga are able to meet their foreign currency obligations.

The Reserve Bank targets a level of foreign reserves equivalent to 3 to 4 months of imports.

Imported goods account for 58% of the CPI basket, so changes in the prices of imported goods and the exchange rate have a significant influence on the overall level of domestic prices.

Price stability contributes to economic welfare and sustainable economic development. Price stability also contributes to better economic performance. When inflation is low and stable it is easier for people to distinguish changes in relative prices and to adjust their decisions regarding consumption, saving, and investment accordingly. Importantly, an environment of stable prices also reduces risk in long-term financial agreements, as lenders and investors will be less likely to demand a high inflation risk premium to compensate for the loss of purchasing power. This reduces the costs to borrowers and increases the incentives for businesses to invest.

The high proportion of Tonga's exports and imports as a share of production mean that domestic prices are likely to move closely with the prices of traded goods, which in turn depend closely on the value of the exchange rate. Vulnerability to external shocks, such as oil price increases, adverse weather conditions, and high dependence on remittances and imports, heighten the importance of promoting external stability, exchange rate stability and therefore overall price stability.

By promoting external stability through maintaining an adequate level of foreign reserves and promoting price stability, the NRBT through its conduct of monetary policy can most effectively contribute towards macroeconomic stability, sustained economic growth and raising prosperity for Tonga.





'eni mei'he fakafuofua 'e toho 'a e ngaahi nō lalahi fo'ou kuo 'osi tali, 'o kau hen'i 'a e nō ki he ngaahi kautaha pisinisi 'a e Pule'anga', fakafuofua 'e holo 'a e ngaahi totongi tupu', pea mo e hū mai 'a e polokalama nō fo'ou 'a e Pule'anga' 'o fakataumu'a ki he ngaahi tafa'aki ngaohi koloa', takimamata', ngoue', toutai' pea mo e nō ki he ngaahi fiema'u fakaako. 'Oku fakafuofua 'e kake si'i 'a e tupu 'i he ngaahi nō, 'i he ta'u 2014-15. 'E kei hokohoko atu ai pē 'a e fengāue'aki vāaofi 'a e Pangikē Pule' mo e ngaahi pangikē ke faka'ai'ai hono fakapotopoto'i 'a hono tuku atu 'o e ngaahi nō.

6. Vakai ki he fokotu'utu'u ngāue 'a e Pule'anga

Na'e holo 'a e lahi 'o e pa'anga ke totongi 'e he ngaahi pangikē ki he Pule'anga' (net credit to government) 'o lahi hake 'i he pēseti 'e 15 'i he ta'u' ki 'Aokosi 2014. 'Oku makatu'unga 'a e ola ko 'eni' mei he kake ofi 'i he pēseti 'e 15 'i he fakahū pa'anga 'a e Pule'anga' 'i he ngaahi pangikē, 'o ma'olunga ange 'i he tupu pēseti 'e 11 'i he pōnite 'a e Pule'anga' 'oku pukepuke 'e he ngaahi pangikē. Ko e kake ko 'eni 'a e fakahū pa'anga 'a e Pule'anga' 'oku makatu'unga ia 'i he lahi 'a e pa'anga hū mai 'a e Pule'anga' mei he ngaahi fonua hoa ngāue fakalakalaka', toe lahi ange 'a e pa'anga na'e tānaki 'e he Pule'anga' fakalotofonua', mo hono fakapotopoto'i hono leva'i 'a e ngaahi fakamole 'a e ngaahi potungāue 'a e Pule'anga', 'i he vaha'a taimi ko 'eni'. Na'e tokoni 'a e kake ko 'eni 'i he fakahū pa'anga 'a e Pule'anga' 'i he ngaahi pangikē ki he ma'olunga 'a e lahi 'o e pa'anga fakalūkufua' mo e pa'anga talifaki 'a e Pule'anga 'i muli'. 'Oku fenāpasi 'a e ola ko 'eni' mo e fakafuofua 'a e fakamatala patiseti 'o e 2014-15 ki ha hulu T\$8.6 miliona 'i he ta'u fakapa'anga 2013-14.

'Oku fakafuofua ko e fe'āmokaki 'i he patiseti 'a e Pule'anga' 'e a'u ki he T\$13.7 miliona 'i he ta'u fakapa'anga 2014-15. Ko ia na'e tuku atu 'e he Pangikē Pule', 'i he konga 'uluaki 'o e ta'u fakapa'anga' ha ngaahi pōnite 'a e Pule'anga' ke tokoni ki hono fakapa'anga 'a e ngaahi fakamole ko 'eni'. Ko e taumu'a 'a hono tuku atu 'o e pōnite' ke fakapa'anga 'a e ngaahi nō 'oku tuku atu 'e he Pule'anga' ki he ngaahi pisinisi taautaha' 'a ia 'oku tokanga'i 'e he Pangikē Langa Fakalakalaka 'o Tonga'. Makatu'unga mei he kei 'i he tu'unga ma'olunga ko ia 'a e pa'anga ngāue 'a e ngaahi pangikē mo e taumu'a ki hono ngāue'aki 'o e pa'anga 'e ma'u mei hono tuku atu 'o e pōnite 'a e Pule'anga', 'oku 'i ai 'a e tui 'e 'ikai uesia 'a e pa'anga ngāue 'a e ngaahi pangikē' 'i hono tuku atu ki tu'a 'a e pōnite 'a e Pule'anga'.

'I hono tali ko 'eni 'a e ngaahi liliu ki he lao 'a e Pangikē Pule 'a Tonga', 'e malava 'e he Pangikē Pule' 'o fakatau 'a e ngaahi pōnite na'e 'ikai fakatau. Ka a'usia e taumu'a 'oku faka'amu ki ai 'a e Pule'anga' mei he ngaahi nō 'oku tuku atu ki he ngaahi pisinisi taautaha', te ne ala uesia 'a e lahi 'o e pa'anga talifaki 'a e Pule'anga' 'i muli', 'e toe lahi ange 'a e nō 'e tuku atu 'e he ngaahi pangikē, pea 'e si'isi'i ange ai 'a e lahi 'o e pa'anga fakalūkufua'. Ko ia, 'oku mahu'inga ki he Pangikē Pule' ke ne faka'ai'ai hono fakapotopoto'i 'o e tuku atu 'e he Pangikē Fakalakalaka 'a Tonga' 'a e ngaahi nō fo'ou mei he pa'anga 'a e Pule'anga' 'oku nau tokanga'i'.

Na'e toe tuku mai foki 'e he Pule'anga' ha ngaahi fokotu'utu'u fo'ou ke faka'ai'ai 'a e inivesi 'i he ngaahi pisinisi taautaha' 'i 'Aokosi 2014, pea ke lele 'eni 'i ha ta'u 'e ua. 'Oku kau ki hen'i 'a hono faka'atā 'a e ngaahi pisinisi' mei he totongi tukuhau 'i ha taimi nounou, mo hono fakafaingofua'i 'a e founiga ngāue ki he ngaahi pisinisi 'oku nau fiema'u ha ngaahi faka'ai'ai ki he'enau 'inivesi' mei he founiga angamaheni 'oku tuku atu'. 'Oku kau foki 'i hen'i mo e tukuhau pa'anga hu mai pisinisi iiki' (Small Business Tax – SBT), ki he ngaahi pisinisi 'oku si'i ange 'enau pa'anga hū mai' 'i he \$100,000 ke fakafaingofua'i 'a e ngaahi fakamatala fakatukuhau 'oku nau teuteu'i'. 'Oku 'i ai e fakafuofua 'e hoko 'eni ke holo ai 'a e tanaki pa'anga 'a e Pule'anga' 'i he vaha'a taimi ko 'eni'. Ka neongo ia', 'e tokoni lahi 'a e ngaahi fokotu'utu'u ngāue ko 'eni' ki he ngaahi palani fakalakalaka 'a e ngaahi pisinisi taautaha' pea 'e toe lelei ange ai 'a e tanaki pa'anga 'a e Pule'anga' 'i he ngaahi ta'u ka hoko mai'.

'Oku fakafuofua 'e lahi 'a e pa'anga hū mai 'a e Pule'anga' 'i he konga faka'osi 'o e ta'u fakapa'anga', tupu mei he hū mai 'o e ngaahi pa'anga tokoni fakapatiseti mei he ngaahi fonua hoa ngāue fakalakalaka' mo e tokoni ko ia ki he polōseki hono toe langa 'o Ha'apai'. Ko ia 'oku fakafuofua 'e kei 'i he tu'unga ma'olunga pē 'a e pa'anga talifaki 'a e Pule'anga' 'i he kaha'u vave mai', 'o 'i 'olunga 'i he māhina 'e 8 'o e koloa hū mai mei tu'apule'anga', 'a ia 'oku ma'olunga 'aupito 'eni 'i he fakangatangata 'o e mahina 'e 3-4. 'Oku fakafuofua 'e toe lahi ange mo e pa'anga ke totongi fakafoki 'e he ngaahi pangikē ki he Pule'anga'.

'I he 'uhinga tatau, ko e hiki pēseti 'e 8.9 ko'eni 'a e ngaahi nō fakakātoa 'a e pule'anga' 'o hangē ko ia na'e hā 'i he fakamatala patiseti 2014-15,

ke tokoni ki hono fua 'a e ngaahi fakamole 'a e Pule'anga', te ne toe fakalahi ai 'a e pa'anga ke totongi fakafoki 'e he ngaahi pangikē ki he Pule'anga'. Koe'uh i ko e lahi hake 'i he pēseti 'e 90 'a e ngaahi mo'ua 'a e Pule'anga' 'oku 'i he ngaahi fonua muli', 'e hoko 'eni ke lahi 'a e hū kitu'a 'a e pa'anga talifaki 'a e Pule'anga' 'i he kaha'u'. 'E kei hokohoko atu ai pē hono faka'ai'ai 'e he Pangikē Pule' 'a e fengāue'aki vāofi 'i he fa'u 'o 'ene ngaahi fokotu'utu'u ngāue fakapa'anga' mo e ngaahi fokotu'utu'u ngāue fakapa'anga 'a e Potungāue Pa'anga' mo e Palani Fakafonua' ke maa'usia 'a e ngaahi taumu'a, mo faka'ai'ai 'a e ngaahi ngāue faka'ekonōmika 'i he fonua'.

7. Ko e tu'unga 'o e Fokotu'utu'u Ngāue Fakapa'anga 'a e Pangikē Pule

Ko e tefito'i taumu'a 'a e Pangikē Pule' felāve'i mo e fokotu'utu'u ngāue fakapa'anga', ko hono fakapapau'i 'oku 'i he tu'unga fe'unga mo fakafiemālie 'a e pa'anga talifaki 'a e Pule'anga' 'i muli', pea mo ta'ota'ofi 'a e hikihiki 'i he tu'unga 'o e totongi koloa'.







Na'e kei tu'uma'u pē 'a e fakangaloku ko ia 'e he Pangikē Pule' 'ene fokotu'utu'u ngāue' talu mei Nōvema 2012, hili ia 'a e 'ikai toe hilifaki 'a e totongi tupu ki he pa'anga ngāue 'a e ngaahi pangikē 'oku fakahū 'i he Pangikē Pule'. Na'e 'ikai ke toe tuku atu 'e he Pangikē Pule' 'ene ngaahi Nouti, pea na'e kei tauhi pē 'e he Pangikē Pule' 'a e pēseti 'o e pa'anga talifaki 'oku fiema'u mei he ngaahi pangikē' 'i he pēseti 'e 5 'o e ngaahi fakahū pa'anga'. Ko e fokotu'utu'u 'eni 'a e Pangikē Pule' ke 'oua na'a fakasi'isi'i 'a e pa'anga ngāue 'a e ngaahi pangike', ke faka'ai'ai 'a e ngaahi pangikē' ke nau ngāue'aki 'a e pa'anga ko 'eni' ke tuku atu ha ngaahi nō fo'ou kitu'a.

Tupu mei he ngaahi fakalakalaka fakamāmāni lahi kimui'ni mai', lahi ange 'a e ngaahi ngāue langa', mo e fakalakalaka 'i he tafa'aki ngoue' mo e takimamata', 'oku fakafuofua ai 'e he Pangikē Pule' 'e lelei e tupu faka'ekonōmika 'a Tonga 'i he kaha'u'.

'E hokohoko atu ai pē mo e toe lahi ange 'a e ngaahi nō 'oku tuku atu ki tu'a 'e he ngaahi pangikē, pea mo e hokohoko atu ai pē ke holo 'a e faikehekehe 'i he totongi tupu ki he nō mo e totongi tupu ki he fakahū pa'anga'. Makatu'unga mei he lahi 'o e pa'anga hū mai ke tokoni fakapatiseti ki he Pule'anga', fakafuofua 'e toe lahi ange mo e pa'anga taautaha li mai mei muli', mo e pa'anga hū mai mei'he folau 'eve'eva', 'e kei 'i he tu'unga mā'olunga pē 'a e pa'anga talifaki 'a e Pule'anga' 'i muli' 'o mā'olunga 'i he fakangatangata si'isi'i taha 'oku fiema'u'. Ko e fakafuofua ki he hikihiki 'i he totongi koloa' 'e kei 'i loto pē mo ia 'i he fakangatangata 'a e Pangikē Pule'.

'I he vakai ko ia ki he ngaahi fakalakalaka ko 'eni', 'oku 'i he tu'unga fe'unga pē ke hokohoko atu 'a hono fakangaloku 'a e fokotu'utu'u ngāue fakapa'anga lolotonga' ki he māhina 'e ono ka hoko mai'. 'E kei hokohoko atu ai pē 'e he Pangikē Pule' 'a hono siofi 'a e ngaahi fakalakalaka faka'ekonōmika' mo e tu'unga fakapa'anga 'a e fonua' pea ke liliu 'a e fokotu'utu'u ki he ngāue fakapa'anga' 'oka fiema'u.

Ko e ngaahi fatongia 'o e Pangikē Pule Fakafonua 'a Tonga' felāve'i mo e fokotu'utu'u ngāue fakapa'anga' 'oku hā ia 'i he Kupu 4 (1) 'o e Lao (Fakatonutonu) ki he Pangikē Pule Fakafonua 'a Tonga 2007, 'a ia 'oku fakahā ai ko e ngaahi tefito'i taumu'a 'o e Pangikē ko hono:

- (a) pukepuke ke ma'uma'uluta 'a e tu'unga fakapa'anga fakalotofonua mo faka-tu'apule'anga'; mo
- (e) langa hake ha sistemi fakapa'anga 'oku malu mo lele lelei;

'Oku toe fakahā 'e he Kupu 4 kuo pau ke fakahoko 'e he Pangikē Pule' 'ene ngaahi ngāue 'i ha founa 'oku ne tokoni'i 'a e malu 'a e tu'unga faka'ekonōmika fakalukūfua' mo e tupu faka'ekonōmika'. 'Oku toe kau ki ai mo e Kupu 30 (2) 'o e Lao 'a ia 'oku tuku ki he Pangikē Pule' 'a e fatongia ki hono fakapapau'i 'oku 'i he tu'unga fakafiemālie 'a e pa'anga talifaki 'a e Pule'anga' 'i muli'.

Fakatatau ki he Lao', kuo pau ki he Pangikē Pule' ke ne pukepuke ke ma'uma'uluta 'a e tu'unga fakapa'anga fakalotofonua mo faka-tu'apule'anga' 'aki 'a hono fakapapau'i 'oku 'i he tu'unga fe'unga mo fakafiemālie 'a e pa'anga talifaki 'a e Pule'anga' 'i muli' pea mo ta'ota'ofi 'a e hikihiki 'i he tu'unga 'o e totongi koloa'.

Ko hono fakapapau'i 'oku 'i he tu'unga fakafiemālie 'a e pa'anga talifaki 'a e Pule'anga' 'i muli', 'oku mahu'inga ia ki he 'ekonōmika 'o ha fonua si'sisi' hangē ko Tonga', 'a ia 'oku fakafalala ki he ngaahi koloa hū mai mei tu'apule'anga ke fakaai 'ene ngaahi fiema'u koloa', 'a ia kuopau ke totongi atu ia 'i he pa'anga muli. Koe'uh i ko e tu'u laveangofua 'a Tonga ki he ngaahi fakatamaki fakafokifā 'oku 'ikai ke ne malava 'o mapule'i mo e ngaahi fakatu'utāmaki fakaenatula, pehe ki he si'sisi' 'a e tu'unga faka'ekonōmika mo e koloa 'oku hū atu ki

tu'apule'anga pea mo e fakafalala ki he ngaahi koloa hū mai mei tu'apule'anga', 'oku mahu'inga 'aupito ai ke fakapapau'i 'oku 'i he tu'unga fe'unga 'a e pa'anga talifaki 'a e Pule'anga' 'i muli' ke feau 'a e ngaahi tefito'i fiema'u taautaha mo tokoni ki he tupu faka'ekonōmika'.

'Oku tokoni foki 'a e tu'unga fakafiemālie 'a e pa'anga talifaki 'a e Pule'anga' 'i muli' ke fakasi'sisi' 'a e fetō'aki 'i he fakafetongi pa'anga' pea ke 'i he tu'unga falala'anga mo pau ke malava 'e he ngaahi pisinisi' mo e kakai taautaha 'i Tonga' 'o feau 'enau ngaahi fiema'u pa'anga muli.

Ko e taumu'a 'a e Pangikē Pule' ki he tu'unga fe'unga mo fakafiemālie 'i he pa'anga talifaki 'a e Pule'anga' 'i muli' 'oku tatau mo e koloa hū mai ki he māhina 'e 3 ki he 4.

Tupu mei'he lahi 'a e ngaahi koloa hū mai 'oku ngāue'aki 'i he me'afua totongi koloa fakalukufua' (pēseti 'e 58), ko e ngaahi fe'unu'aki 'i he ngaahi totongi koloa hū mai mo e fakafetongi pa'anga' 'oku 'i ai 'ene kaunga lahi ki he tu'unga fakalukufua 'o e ngaahi totongi koloa fakalotofonua'.

Ko hono ta'ota'ofi 'a e hikihiki 'i he tu'unga 'o e totongi koloa', 'oku tokoni ia ki he ola lelei 'a e tu'unga faka'ekonōmika mo e fakalakalaka faka'ekonōmika 'oku tu'otu'atatau. 'Oku tokoni foki hono ta'ota'ofi 'o e hikihiki 'i he tu'unga 'o e totongi koloa' ki he leleiange 'a e ngaahi ngāue faka'ekonōmika'. 'Oku faingofuaange ki he kakai' ke nau fakafaikehekehe'i 'a e ngaahi liliu 'i he ngaahi totongi koloa' pea ke liliu 'enau fai tu'utu'uni fekau'aki mo e fakatau koloa', fakahū pa'anga' mo e 'inivesi', 'i he taimi 'oku ma'ulalo ai mo 'ikai feliuliuki lahi ai 'a e hikihiki 'i he totongi koloa'. Ko e me'a 'oku mahu'inga', ko ha 'ātakai 'oku ta'ota'ofi ai 'a e hikihiki 'i he tu'unga 'o e totongi koloa', 'oku si'sisi'ange ai 'a e faingata'a 'o e aleapau fakapa'anga taimi loloa',

koe'uhī 'e sī'isi'iange ha fiema'u 'e he kau nō pa'anga atu' mo e kau 'inivesitoa' ha fu'u totongi ma'olunga ke malu'i'aki ha holo 'a e ivi fakatau 'o e pa'anga'. 'Oku ne fakasi'isi'i leva 'a e ngaahi totongi ki he kau nō pa'anga' pea hiki hake hono faka'ai'ai 'a e ngaahi pisinisi' ke nau 'inivesi.

Ko e tu'unga ma'olunga koia 'o e lahi 'o e ngaahi koloa hū atu mo e ngaahi koloa hū mai 'a Tonga 'oku fiema'u ki he'ene fakatupu koloa' 'oku 'uhinga ia ko e ngaahi totongi koloa fakalotofonua' 'oku ngalingali ke nga'unu vaofi mo e totongi koloa hū mai', 'a ia 'oku makatu'unga ia 'i he mahu'inga 'o e fakafetongi pa'anga'. Koe'uhī ko e tu'u lavea ngofua 'a e fonua' ki he ngaahi fakatamaki fakafokifā 'oku 'ikai ke ne malava 'o mapule'i, hangē ko e hikihiki 'i he totongi lolo', ngaahi fakatu'utamaki fakaenatula, lahi 'a e fakafalala ki he ngaahi koloa hū mai mei tu'apule'anga mo e li pa'anga mai mei muli', 'oku mahu'inga ai hono faka'ai'ai 'a e tu'unga lelei mo mālohi 'i he fehū'aki pa'anga mo muli', fakafetongi pa'anga' mo e tu'unga fakalūkufua 'o e totongi koloa'.

Ko hono fakapapau'i koia 'a e tu'unga lelei mo mālohi 'a e tu'unga fefakatau'aki fakapa'anga mo tu'apule'anga' 'aki hono pukepuke 'a e pa'anga talifaki 'a e Pule'anga' 'i muli' 'i he tu'unga 'oku fakafiemālie pea mo ta'ota'ofi 'a e hikihiki 'i he tu'unga 'o e totongi koloa', ko e founiga lelei taha ia 'e malava ai 'a e ngaahi fokotu'utu'u ngāue fakapa'anga 'a e Pangikē Pule' ke tokoni'i mo faka'ai'ai 'a e tu'unga ma'uma'uluta mo falala'anga 'a e tu'unga faka'ekonōmika fakalūkufua 'a e fonua', tupu faka'ekonōmika 'oku tu'otu'atatau pea mo hakeaki'i 'a e tu'umalie ki Tonga.
